Andrew passed away Friday, February 21, at his residence after eight courageous years of battling cancer. Born in Lincolnshire, England he was a 1985 graduate of Transylvania University where he was president of student government and the Alumni Association. He graduated from the University of Louisville Law School in 1988, was a member of the Kentucky Bar Association and First Christian Church, Frankfort. He coached Franklin and Shelby County high schools soccer programs and was an Administrative Law Judge for the Commonwealth of Kentucky Cabinet of Health and Family Services.

Survivors include his parents Derek T. and Marion Smith, Frankfort; sister and brother in law Carole A. and Nelson Henderson, nephew AJ Henderson, niece Lauren B. Henderson and several cousins.
